**Note: Students must pass the final test with an 80%.**

This course is designed primarily for law enforcement officers that meet the IACP/NHTSA National Standardized Field Sobriety Testing Program Standards, including a proficiency test, and who have successfully completed an IACP/NHTSA approved training course.

This program is an intermediate level course designed to offer more than basic understanding of the impairing effects of drugs (Illicit and Licit), alcohol, and/or the combination of both for the impaired drivers. The officer must be able to administer and interpret the Horizontal Gaze Nystagmus (HGN) test for alcohol-impaired suspects. The student should be fully conversant with the procedural "mechanics" of HGN with the three clues of HGN and with the interpretation of those clues for assessing alcohol impairment. A major focus of this program is on the examination of a drug-impaired suspect's eyes. The procedure for those eye examinations derives largely from HGN procedures.

This program is a stepping-stone for those interested in possibly becoming a Drug Recognition Expert (DRE) and bridges the gap between the SFST program and the Drug Evaluation and Classification Program.

An SFST proficiency exam will be given on the first day of class and must be passed to continue in the class.

**Upon completion of this course, the student should be able to:**

1. Define and describe the relationship of drugs to impaired driving incidents.
2. Demonstrate, articulate, and properly administer the Standardized Field Sobriety Tests proficiently.
3. Observe, identify, and articulate the observable signs of drug impairment with the established seven drug categories associated with DEC program.
4. Recognize possible medical conditions, which may mimic the obvious observable signs of impairment.
5. Identify, document, and describe indicators observed and information obtained related to impairment which leads to the arrest/release decision.

This course is designed to meet requirements as mandated by the Maryland Police and Correctional Training Commissions and to meet the annual in-service requirements.

**Class Size:** Restricted size, seating is limited.

**Attendance:** You must attend the entire class to receive in-service credit.

#### **Dress Code:**

To maintain a professional appearance, all in-service officers/staff must follow the prescribed dress code to be admitted to any training held at the Academy.

- Uniform of the day recommended
- Shirt with a collar—**No** t-shirts or tank tops
- Docker style pants, BDU's or suit—**No** shorts or jeans

**Firearms**—All officers wearing a handgun on campus in plain view **MUST** also wear his/her badge in plain view.
